



TERMS OF PARTICIPATION

Please read the terms of participation carefully, sign and hand to the park's staff. People under the age of 18 must have parental consent and signature in the terms. Always ask the staff if something is unclear.

Before the activity

You are fully responsible for yourself / your child's activity and safety in Isaberg Tree Top Adventure. The year you turn 12 years you can climb without an adult. Younger children must always be accompanied during climbing by an adult. Parents may supervise a maximum of two children. You must always follow the instructions and park rules. Wear comfortable clothing (depending on weather) and sneakers (or similar). You must have an approval from our park staff before you can start to climb by yourself in the park.

During the activity

The harness must be tight throughout your visit in the park, if necessary tighten it during the activity. If the harness is removed or loosened (eg when using the toilet), the harness must be checked by park staff before you start climbing again. You must always be secured by the carabiners. Throughout the activity there must always be two carabiners secured to the line. When moving a carabiner, one must always remain secured on the line. When going on a zipline, the roller must be attached behind the carabiners. If necessary, slow down by placing your hand behind the roller. When you set out on the zipline, you should make sure that there is no one in front of you. Only one person is allowed to remain in a challenge at a time. Maximum three persons are allowed on a tree platform at a time.

Equipment

Two carabiners, line roller, complete harness, helmet and gloves – are included in the rental. (= 120 min), and is part of the paid ticket price. It is forbidden to leave the area with the equipment. Damage to the equipment must be reported immediately. If the time is exceeded, a back payment of 200 SEK per half hour must be paid.

Terms and conditions

You may not be pregnant, having heart or lung failure or a bad neck or back (reduced physical condition of some sort).

You may not be under the influence of drugs or alcohol.

You may not weigh more than 120 kg.

The year you turn 8 years you can climb the green, blue and red course. The year you turn 12 years you are allowed to climb all courses.

School reservations include only green, blue and red courses. Black course can be added for the group.

You are not allowed to smoke wearing the equipment.

Long hair should be kept together with band or in a hat.

We use all our senses in the activity; sight, hearing and touch.

Isaberg Mountain Resort is not responsible for any damage to clothing, personal items or theft.

Access to the facility after closure is prohibited.

Park staff holds the right to exclude persons from the park which who do not follow the rules. Park staff can close the park when there is danger (eg fire, storm, lightning, etc.)
