



TERMS OF PARTICIPATION

Please read the terms of participation carefully, sign and hand over to the park's staff. People under the age of 18 must have a liable adults/parents' consent and signature in the terms. Always ask the staff if something is unclear.



Terms and conditions

- All climbing is at your own risk.
- You may not be pregnant, have a history of heart and lung failure, or problems with neck and back. We do not recommend climbing with ongoing injuries or a considerable history of injuries. If you have problems with asthma, epilepsy and/or diabetes, please inform the staff before start.
- You may not be under the influence of drugs or alcohol.
- You may not weigh more than 120 kg.
- You are not allowed to smoke in the area and absolutely not while wearing the equipment.
- Access to the facility after closure is prohibited.
- We use all our senses in the activity; sight, hearing and touch, please notify the staff due to a disability before starting.
- Loose objects or objects that can get caught is not allowed, such as jewellery, hoods, buffs/baklava or alike. Items can be stored in a sealed pocket or in the safety lockers.
- Long hair should be kept together with band.
- Isaberg Mountain Resort is not responsible for any damage to clothing, personal items or theft. Therefore, wear durable clothes (appropriate for the weather) and close-fitting shoes.

Before the activity

- By Accepting the terms of participation, you take full responsibility for you and your youths' safety at Isaberg Tree Top Adventure by following the rules and listening to the staff of the park.
- Age limit on the courses:
 - Green course: must have turned 6 years old
 - Blue course: as of the year one turns 8
 - Red course: as of the year one turns 8.
 - Black course: as of the year one turns 12.
- Children younger than 12 years must always be accompanied by a climbing adult (+18 years).
- A liable adult may supervise a maximum of two children.
- From the year you turn 12 years old you can climb all courses without an adult.

During the activity

- All participants must attend the safety briefing and follow the parks rules.
- The harness must be tight throughout your visit in the park, if necessary tighten it during the activity. If the harness is removed or loosened (eg. when using the toilet), the harness must be checked by park staff before you start climbing again.
- Park staff holds the right to exclude individuals from the park who fail to comply with the rules. Park staff has the authority to close the park in case of danger (eg fire, storm, lightning, etc.)

Equipment

- Two carabiners, a pulley, a complete harness, helmet and gloves – are included in the rental (2h45m) and is part of the paid ticket price.
- It is forbidden to leave the area with the equipment.
- Damage to the equipment must be reported immediately.
- If the time is exceeded, a payment of 200 SEK per half hour must be paid.

I am an adult and have read and understood the terms of participation applicable to Isaberg Tree Top Adventure. I understand that Isaberg Tree Top Adventure (Isaberg Mountain Resort) cannot be held responsible for the consequences of non-compliance. I also understand that I may at any time be denied access to the park, without reimbursement of ticket, if I do not follow the rules. You also agree to that photos taken may be used by Isaberg Tree Top Adventure for its purpose (otherwise, inform the staff).

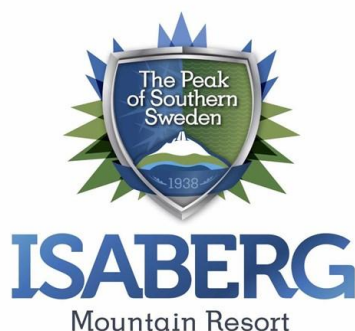
